Welcome, apologies and minutes of last meeting

Alasdair welcomed attendees, recognised MSPs in attendance and noted apologies where these had been given. The minutes of the previous CPG were proposed by Heather Cubie, Chair of SMP and seconded by Dr Tracy Morse.

Presentation on the University of Dundee's evolving links with Malawi's six public universities

Prof Iain Gillespie, Principal and Vice-Chancellor gave a presentation about the University of Dundee's commitment to Malawian Partnerships. This is based on the University of Dundee Strategy to 2027 Social Purpose pillars: Research; Education and empowerment & engagement. The University's Africa Vision is to strengthen and form new alliances and partnerships, based on mutual respect and recognition of the need for co-design and co-delivery that meet all needs, particularly of those most disadvantaged. Prof Gillespie emphasized the University's aim to looking to the future whilst recognizing the past and living the University's long-held values.

In August 2022 the Vice Chancellors of all six of Malawi's public universities and the principal and Vice Chancellor of the University of Dundee signed the Blantyre Declaration – A shared commitment to social purpose. This was illustrated by examples of some of the steps taken to meeting these commitments. Amongst others the twinning of the Botanic gardens, the launch of a new doctoral scheme for staff at partner institutions and developing research, education and engagement priorities, building on mutual strengths and needs. At his recent visit Prof Gillespie was inspired by the political support given, having had the opportunity to speak to HE Dr Chakwera and participating at a round-table discussion with six cabinet ministers focusing on climate justice.

Input and Reflections from Malawi

Speaking from Malawi, Dr Sosten Chiotha from LEAD then addressed the CPG. He reported back from successful talks with cabinet ministers who acknowledged the tangible outcomes from the genesis of the partnership already as well as expressed their overwhelming support.

As an example Dr Chiotha mentioned the work done by University of Dundee on the inclusion of women as women were key in the education for climate action. Officials of the National planning commission are excited as they work with universities and private sector and feel this partnership has come at the right time.

We heard from all Vice Chancellors of all six public universities who each in their own words expressed their excitement of transforming the lives of students and people in Malawi by having this partnership and hopefully more to follow. Collaboration and practical partnership, not just on paper will contribute to the Malawi Vision 2063 and tie into the national education sector investment plan.

Cooperatives College – University of Dundee links

Ali Longdon reported from Cooperatives College, an educational charity whose mission is empowering individuals and communities to build a fairer world based on the cooperatives values and principles of co-production, co-facilitation and co-design. Their four main strategies are co-operative learning, thought leadership, international collaborative development and youth empowerment. Two areas of their work particularly applied to this meeting:

- Developing partnerships in higher education and the establishment of a scholarship programme.
- Building and growing stronger networks to develop existing and new co-operatives and networks to share knowledge and best practice.

Q&A

Peter West, consul of Malawi in Scotland mentioned the excellent initiative in 2010 funded by the Scottish Government which sent academics from Scotland to study and practice for a semester in Malawi and bring Malawian colleagues back for a semester or longer.

Q: Would you be open to widening the initiative to bring in other universities in the initiative? A: (Prof Iain Gillespie - IG) Yes, we want to make Blantyre Declaration work and look at it with other partners and funders – one step at a time.

Sarah Boyack MSP found presentations exciting, partnership, co-design approach was crucial. Q: Will there be feedback on impact? It would be an interesting model for other institutions to follow suit.

A: (IG) Yes, plan is to have summit of seven universities in summer, to measure the impact of moving into the implementation of the declaration, one step at a time. . Will keep CPG Malawi group informed on progress. Keeping it pragmatic and realistic to get things moving.

Heather Cubie, Chair SMP, Fellow of Royal Society of Edinburgh's Africa Committee.

Q: It would be a wonderful opportunity for cross partnership across senior academics too and she would be happy to help advance tangential partnership.

A: IG preliminary discussion with president of RSE how does RSE work more closely with leadership of Scottish Universities? Important independent academic voice, work more closely on common issues. Sustainable partnership with Malawian colleagues. Co-design across.

John Mason MSP, spin off business start-up – does this happen in Malawi

Q: Is research in Malawi leading to businesses starting up? What are needs?

A: (Address Malata, VC, Malawi University of Science and Technology) This is happening but due to small Malawi economy we are doing as much as we can, learning lessons from other universities.

A: (Emmanuel Kaunda, VC, Lilongwe University of Agriculture and Natural Resources (LUNAR)) There is a lot of interaction between private sector and industry. This is a great opportunity to learn from other Universities.

Demi Elemo, University of Dundee, fantastic presentation.

Q: What is being done to commercialise research results? Are there plans to spread partnership/impact to other countries on continent.

A: (IG) Africa initiative at University of Dundee with seven universities in Malawi, strong link with Ghana as well as Nigeria. We are looking to learn from what we are doing. Things to learn from initiatives.
