#### ITEM ONE: M-HEALTH

**Lesley-Anne Long** joined us online from Washington DC to give a talk on mobile health (mHealth), see presentation attached for more details.

Lesley-Anne spoke about the work of **mPowering Frontline Health Workers**, whose aim is ending preventable maternal and child deaths. They offer online training materials for health workers which are free to download and mobile-ready. Resources can be downloaded onto a mobile device, in a range of languages, and accessed without connectivity. This can be access through 'ORB' - a library of high quality, mobile-optimized training materials for frontline health workers.

#### ITEM TWO: SCOTTISH GLOBAL HEALTH COLLABORATIVE

David Hope-Jones, from the Scotland Malawi Partnership (SMP), gave an update on the **Scottish Global Health Collaborative**: this new initiative, chaired and championed by the Chief Medical Officer (CMO) of Scotland, will provide coordination and support for global health work across Scotland, as well as linking with global health work across the UK and internationally. Currently there are two main activities, setting up a website to represent the members of collaborative (led by SMP) and a mapping exercise is underway to map global health work all over Scotland (led by THET).

Mike McKirdy, from the Royal College of Physician and Surgeons of Glasgow, spoke about how Wales are leading the way in this area at the moment. Wales is the first nation in the world to put in place a legislative link to the UN SDGs - the Well-being of Future Generations (Wales) Act (WFG). In 2014 The Charter for International Health Partnerships in Wales was ratified by all seven regional Health Boards and Trusts. The International Health Coordination Centre (IHCC) has been working to raise awareness of and support international health partnerships and global citizenship in Wales, including establishing a framework for volunteering. This initiative is the first of its kind and serves as an example for unified commitment and a model for ensuring sound governance, good practice and reciprocal and responsible international work. #### ITEM THREE: ROYAL COLLEGE OF SURGEONS, EDINBURGH

Michael Stitt (Head of Development) joined us to give a short overview of the work of the Royal College of Surgeons Edinburgh (RCSEd) The RCSEd is the oldest and largest of the UK surgical Royal Colleges, and one of the largest of all the UK medical Royal Colleges. Today it is a modern, thriving, global network of medical professionals with a membership of well over 23,000 professionals who live and work in more than 100 countries around the world. The RCSEd are keen to work together on Global Health issues as part of the Collaborateive (see above) and also through the SMP Health Links Forum. Denis Robson made the point that key national institutions such as the RCSEd and the Royal College of Physician and Surgeons of Glasgow, should look for more opportunities to work together.

#### ITEM FOUR: UPDATE ON SCOTTISH GOVERNMENT FUNDED HEALTH PROJECTS

The forum facilitated sharing and learning from four health projects in Malawi, all funded by the Scottish Government Malawi Development Programme (MDP):

The Edinburgh Malawi Breast Cancer Project, NHS Scotland Lothian: The project aims to achieve and demonstrate improvement in breast cancer treatment at Queen Elizabeth Central Hospital, Blantyre through development of multi-disciplinary care and enhanced pathology. Triage and treatment, training and engagement. A package for sustainable healthcare improvement in Malawi's primary health clinics, Meningitis Research Foundation: The project will deliver a proven health package for early recognition, treatment and appropriate referral of severely ill children in community health centres, acceptable and ready for implementation across Malawi. Impact on Malaria, Maternal Health and the Prognosis for AIDS by Quality Assurance, Knowledge exchange and Training (IMMPAQKT), University of Strathclyde: The objective of this project is to improve the health of the people of Malawi in the three key areas of malaria, maternal health and AIDs; by developing a programme for the quality assurance of traditional herbal medicines and by increasing the knowledge of the conventional medical profession in traditional medicine. Healthy Settings work in Chikhwawa, under the Scotland Chikhwawa Health Initiative, University of Strathclyde: Improved health status can be addressed through the Healthy Settings approach. Healthy Settings not only addresses access to curative health services, but also environmental, sociological and economic determinants for health in the home, school and work environments using a community led approach. This can lead to substantial reductions in the burden on curative health services and reduce the morbidity and mortality of both communicable and non-communicable diseases in communities. - On Sep 9<sup>th</sup> a successful symposium, attended by over 100 participants, was held on Lilongwe on 'reducing the burden of cervical cancer by introduction of thermal coagulation'. This was partnership between the University of Edinburgh, NHS Lothian and Nkhoma Hospital, as part of a project funded by Scottish Government. It was attended by the First Lady who opened the symposium and spoke about the need to work in partnership.
