ITEM ONE: SCOTLAND MALAWI PARTNERSHIP 10 YEAR OF HEALTH PARTNERSHIPS

Charlie Bevan from the SMP launched the “Scotland Malawi Partnership 10 year of Health Partnerships” report. [Click here](#) to download the report.

The report offers some background and brief analysis over health trends over the past 10 years, showing a strong overlap between what Government of Malawi set out as priorities in 2005 and what has been delivered, e.g.

- Maternal health
- Capacity of health colleges (particularly with CoM and KCN)
- HIV/AIDs work- particularly in the first 5 years
- Support for community health

The report also gives voice to some of those who have been participants and beneficiaries in a number of the projects and begins to look forward to the next 10 years, recognising the opportunities of the changing international landscape (SDGs) and at national level with the review of the Malawi Growth and Development Strategy for the third revision in 2016.

ITEM TWO: THE UN’S GLOBAL GOALS- GOAL 3 “GOOD HEALTH AND WELL-BEING”

Dr Liz Grant, Director of the University of Edinburgh’s Global Health Academy offered an overview of the Sustainable Development Goals framework with a particular focus on Goal 3 “Good health and well-being.”

ITEM THREE: HEALTH VOLUNTEERING OVERSEAS

David Hope-Jones updated the forum on the recent NHS Scotland Global Health Collaboration meeting, which has been convened to advance Scotland’s efforts in supporting global health links. The meeting was chaired by Dr Duncan McCormick, Senior Medical Officer of Health Protection Scotland. The SMP have been invited to sit on the core group to take forward the actions discussed at the first meeting, including a mapping exercise of current international health links across NHS boards. This will provide an opportunity for the views of SMP members to be fed into the Scottish Government’s strategic plan in this area.

Viki Taylor from THET also gave an overview of their work in this area and their ambition to offer further support to NHS Scotland staff, and will also be active on the Global Health Collaboration Core Group. For further details on the support offered by THET visit <http://www.thet.org>.

Following David and Viki's input, discussion from the group focussed on the following priorities:

- Importance of being demand-led in any partnership links;
- Upholding good practice in international volunteering;
- Value of addressing blockers to such volunteering;
- Value of also considering associated non-clinical areas: hospital management, logistical assistance, capacity building, resilience, etc

ITEM FOUR: PROJECT GOVERNANCE FOR HEALTH PARTNERSHIPS

Keith Bohannon from the Scotland Malawi Partnership shared a short paper on financial management support. Following feedback from members and partners in Scotland and Malawi the SMP were asked to find out a bit more information about support on offer to develop financial management capacity in Scotland-Malawi links. In response to this we have been in touch with a number of organisations, UK-based and Malawian, to find out what services are on offer. All of the organisations below have been used and recommended by SMP members/partners, based on their experience of working directly with them.

ITEM FIVE: AOB

Ethical clearance for research in Malawi

A number of members have contacted the SMP for advice on ethical clearance boards in Malawi, in relation to either the College of Medicine Research Ethics Committee (COMREC) or National Commission for Science and Technology (NCST). Feedback has shown that fees have increased, there are long waiting times and organisations are struggling to get clear information on whether SG-funded projects are exempt from this charge.

Charges typically are:

- \$100-150 submission fees
- 10% of specific research undertaken- shouldn't be the full project budget

Visas for visiting Malawi

A number of members have now travelled to Malawi under the new visa regime for UK citizens. The simplest option seems to be paying for your visa on arrival into Lilongwe/Blantyre, paying in cash with 75USD for the single entry visa.
